Unrestricted grant comes during May's Mental Health Awareness Month

Madison, WI, May 1, 2024—During a Board of Education meeting on April 29, WEA Member Benefits Foundation, Inc., granted \$20,000 to the Green Bay Area Public School District (GBAPS) to support their mental health initiatives and programs. The initial funding will help create a new mental health navigator position, a comprehensive mental health resource webpage, and increased service hours from community-based providers.

The timely, unrestricted grant comes during May's Mental Health Awareness Month. In addition, the Foundation is launching a local funder outreach effort in hopes that this grant will spark participation from other corporate funders and philanthropic organizations in the community.

GBAPS is the eighth district in the Foundation's statewide school mental health funding initiative, joining Appleton, Madison, Racine, Stevens Point, Sun Prairie, Watertown, and Wausau. The initiative has helped those districts raise nearly \$1 million and reach 5,000 additional students with mental health services and support.
